Bonus Terms & Conditions:

This **100% Deposit Bonus** (hereinafter the “Vaccine Bonus 100%” is open to new and existing clients who deposit a minimum of USD 300 into their Live trading account with Profitto.

Vaccine Bonus 100% is subject to the terms and conditions contained in the present document and subject to all existing Profitto [terms and conditions](#). The date and Time which stated below are according to GMT +8.

General

1. Deposit bonus can only be claimed by verified and funded clients.
2. The bonus amount available is 100% for each deposit amount **USD 300 and more**.
3. The minimum deposit of this offer is **USD300**.
4. The bonus is claimable up to USD10,000 credit bonus.
5. The bonus cannot be claimed via internal transfer and transfer from other contests/promotions, etc.
6. It is advised to claim a bonus right after your deposit is credited to your trading account.

8. Max leverage is 1:300.
9. It is required to trade (bonus amount) / 2 (bonus amount divided by two) standard lots to be able to withdraw a bonus.
10. withdraw later bonuses before you trade the required volume for the first bonus, and so on. The volume calculation starts from the moment the bonus is requested. The volume for each deposit is calculated separately. E.g., You made a \$ 300 deposit on Monday and started trading. On Wednesday you claimed \$300 bonus. Volume calculation for your bonus starts from Monday, any volume traded before Monday will not be

Procedure of Participation

Deposit & Withdrawal

1. Minimum Funding for **each Contest Account** is **300 USD**.
2. The bonus will take place on 5th of April 2021 - 31st December 2021.
3. bonus amount available is 100% for each deposit amount **USD300 and more**.
4. The min deposit of this offer is USD300.
5. The bonus shall be credited into your account and locked until the volume requirements are met. After the required volume is completed, the bonus will be deducted from your MT4 credit and simultaneously deposited into your balance. The operation will be processed within 24 business hours.
6. Max leverage is 1:300.
7. It is required to trade (bonus amount) / 2 (bonus amount divided by two) standard lots to be able to withdraw a bonus. e.g., clients deposited USD 1,000 and will get the Bonus USD 1,000.  - a. - c.
